




# Luc De Schepper Advanced Posology in Homeopathy

Dr. Luc De Schepper discusses in this course Hahnemann's advanced methods of posology according to the 5th and 6th edition of the Organon. They are also called: The Split Dose Method or The Watery Solutions.

These lectures of Dr. Luc's on advanced posology in classical homeopathy also contain tips about the core delusion or cyber delusion, the simillimum etc.

The course consists of lectures, a live-recorded patient example with case analysis; optional\* quiz questions and a summary document with a few optional\* assignments.

In total the course consists of approximately 12 hours of video lectures and optional\* 3 hours for the quiz questions and final assignments (in total hours). The course moderator will be there to assist you with any questions. Some lectures are partly overlapping but are also complementary to each other.

The case analysis by Dr Luc offers you a great opportunity to learn from his systematic approach to case analysis. In a later course this will be explained in more depth.

This course discusses Hahnemann's advanced methods of posology according to the 5th and 6th edition of the Organon. This kind of posology is also known as *The Split Dose Method* or *The Watery Solutions*.

- The course includes an example of Dr. Luc's systematic approach to case analysis, and contain also tips about the core delusion (or cyber delusion), the simillimum etc.
- The course consists of approximately 12 hours of video lectures.
- There are optional\* quiz questions and assignments after each course section, these will take about 3 hours.

- Know how to apply the 'teaspoon method'.
- Know how to apply the 'drop method'.
- Gain experience with case management through real case example exercises.
- Know which efficient questions to ask during the follow-up visit to better evaluate the reaction of the patient, e.g. be familiar with "the follow-up questions".
- A real live-recorded case and case analysis will allow participants to gain experience in a particular approach to general case analysis using systematic steps.
- A real live case follow-up will show a real situation of errors in posology and how to correct this.
- A real live case will allow the participants to learn a certain important polychrest remedy in depth.

# Advanced Posology Part 1: Introduction to the 4th, 5th, 6th Organon edition

During the first seminar in Hechtel, Belgium (2011), Luc gave a summary of potency selection and dosing (posology) for chronic and acute cases. Luc also answers several questions from participants. Included is the Core Delusion of Lycopodium.

# Advanced Posology Part 3: Potency selection and second prescription (2012 Hechtel) + remedy relationships

This lecture gives a comprehensive overview of the last years of Hahnemann's development in dosing (posology). Dr. Luc explains how to use and achieve the benefits of the 5th and 6th edition method of dosing.

### **Advanced Posology Part 4: Exercises potency selection**

### Advanced Posology Part 5: Follow-up questions for patient evaluation

Worldwide, most things that go wrong in the homeopathic practice happen during the patient evaluation and particularly at the second and further follow-up consultations, called *management of the patient*. In this lecture Dr. Luc discusses what you need to check carefully (guidelines) with your patient so that you can evaluate the response correctly. These guidelines are also given to the patient at the first consultation.

## Advanced Posology Part 6: Example live-recorded case with follow-up overview

This patient is a great example of a certain remedy. Luc analyses the case step-by-step following the "Case Analysis Questions".

You will also see how the "Core Delusion" method is built on top of a normal, full case analysis. The case also illustrates well how Dr. Luc uses the 'extended meaning' of repertory rubrics.

In this lecture a comprehensive overview is given of the last years of Hahnemann's development in dosing (posology). Dr. Luc explains how to use and achieve the benefits of the 5th and 6th edition method of dosing.

### Basic knowledge needed

This course in advanced posology expects that you are already familiar with the fundamental principles of homeopathy, e.g. the simillimum principle, primary and secondary action (Organon § 64-66), regarding the minimal dose and the 4<sup>th</sup> edition (Kentian) method of dosing (you can read the appropriate chapters in Kent's *Lectures on Philosophy*). This course focuses on the more advanced 5<sup>th</sup> and 6<sup>th</sup> edition posology, the watery solutions method that Hahnemann applied in his later years.
